# **Chateau Chaparral Owners Association Building Requirements**

- 1. Chateau Chaparral Owners Association, Architectural Committee requires a building application and CCOA building authorization form before beginning building for the following: a. Fences above 30"
  - b. Decks
  - c. Carports
  - d. Sheds
  - e. Auxiliary or accessory structures under 200 sf

### 2. FENCING REQUIREMENTS:

- A. Materials accepted for fencing:
  - a. TREATED WOOD
  - b. METAL
  - c. CHAIN LINK
  - d. CEDAR
  - e. VINYL
  - f. COMPOSITE
  - g. REDWOOD AND TEAK
  - h. WOVEN WIRE
- B. If fencing height is above 30" footers are required. See footer requirements below.
- C. If chain link fencing is installed it must be the standard height requirements of 4' or 5'.
- D. All fencing must have standard gates installed for accessibility and safety purposes.
- E. Fencing without ventilation requires footers every 3'. See footer requirements section of this document for specifics.
- F. Fencing may be a maximum of five (5) feet in height.

### 3. CARPORT REQUIREMENTS


- a. Materials accepted for carports are:
  - i. Metal
  - ii. Treated wood

- b. Setback requirements are the same for carports. 2' between lots and 5' for roadways and walkways.
- c. NO Chaffee County Permit is required by CCOA.
- d. If a professional installer requires a Chaffee County Permit, a CCOA Chaffee County Waiver is located on our website. It must be attached with your CCOA architectural building application.
- e. If the professional installer does not require a Chaffee County permit, then you are not required to sign the CCOA Chaffee County Waiver.
- f. Maximum height for carports is 16' from ground level for RV carports.
- g. Maximum height for carports is 12' from ground level for standard vehicle carports.
- h. The carport will be less than 20 feet long and 12 feet wide.
- i. No electric cables can run into the carport.
- j. It will be a free-standing structure (not attached to anything)
- k. Carports must be anchored by all thread rods.
- 1. Carports are not allowed to have flat roofs. Must meet Chaffee County pitch and snow load requirements.

### 4. SHED REQUIREMENTS

- a. Footer requirements are noted in the CCOA Shed Requirements Document. There are no foundations allowed for sheds.
- b. CCOA does not require county authorization forms for shed construction.
- c. Plans and Drawings for locations and size must be submitted to the Architectural Committee for review prior to placement or construction. (Include building materials and elevation drawings)
- d. When constructing, you must have a CCOA building "authorization form" visible.
- e. Electrical authorization forms must be included in your application for review by CCOA Architectural Committee if electricity is included.
- f. Min Setback from road 5 ft
- g. Min setback from lot/ally 2 ft
- h. Max 200 sf per shed, if setbacks and lot size requirements are met.
- i. Max height 12 ft
- j. Must be on skids. No foundations.
- k. May not be attached to the main living unit.
- 1. Must be clean in appearance.
- m. No water plumbing.
- n. No gas/propane plumbing
- o. No sewer
- p. Electrical Ok. Must be installed by a professional Electrician. May require Chaffee County Permitting and inspection. Ask your electrician. Electric permit is required with your CCOA application.

- q. Sheds will be one-story detached accessory structures used as tool sheds, storage sheds, playhouses and similar uses, provided the floor area does not exceed 200 square feet.
- r. Cannot be permanently affixed to the ground.
- s. Shed Skid Plan Suggestion:



## 5. FOOTER REQUIREMENTS

- a. All footers for Nathrop, Coloardo's altitude of 7,812 refer to the **Chaffee County Minimum Footing/Foundation Requirements document**. This is found here: <a href="https://www.chaffeecounty.org/EndUserFiles/64215.pdf">https://www.chaffeecounty.org/EndUserFiles/64215.pdf</a>
- b. Minimum Footing Depths are 24" below finished grade.
- c. Footers are required for the following:
  - i. Footers are required for fences that are 5'.
  - ii. Footers are required for fencing without ventilation every 3'. iii. Footers are required for carports. iv. Fencing footers at the end of every run must be concrete footers if ventilated.
  - v. Pergolas must be on peer footers and require a CCOA building application.
- 6. In accordance with the By-Laws of Chateau Chaparral, if an owner builds without a CCOA authorization form from the Architectural Committee a Cease and Desist Order will be issued. Building without a CCOA authorization form from the Architectural Committee will be subject to a 250.00 fine per our CCOA compliance fine and fee schedule.
