Fines are retroactive to the date of the first notification if not corrected by the date specified on the first notice.

Lot not equipped with winter water for winter occupancy	Arch. Codes Sec 2, part I	\$250 + \$50/month
Parking in streets, roadways, alleyways, is prohibited by owners or guests at all times. Safety and Hazard issue.	Rules & Regs	\$100/occurrence
Pets, dogs and cats, not under control of the owner at all times by means of a leash or fence.	Animal Policy 2024	\$100/occurrence
Lot not maintained: <ul style="list-style-type: none"> - Fire hazard free manner e.g. Dead trees, tree limbs, dead weeds and unusable lumber - Structures kept in repair, and painted to a clean appearance - Weed growth in excess of 10" - Firewood stacked away from the primary unit 	Rules & Regs Sec 4, para J, viii, ix, x	\$50/month
Owner vehicle parked in a common area without approval of the Board of Managers	Rules & Regs Sec 4, para C	\$250/month

Utilizing hydrant water between October 16 – April 14	Water Service Policy	\$350.00 Immediate fee
Making noise with music, generators, ect. during quiet hours (10:00 PM – 6:00 AM)	J. General, xix.	\$100.00/occurrence
Open excavation trench without county permit, off season trench, and or open for more than 90 days.	Arch. Codes B. Construction, vi.	\$200.00/month
